# 2010-004 **SUPERINTENDENT'S REPORT**

Mr. Robinson welcomed everyone and thanked them for their interest in South Spencer County School Corporation. Mr. Robinson personally thanked the Board members for their service to the students, staff, community and corporation of South Spencer this past year. The following items were reported:

- Monday January 18, we will celebrate Martin Luther King Day
- Snow makeup days will be Monday, Feb. 15 and Friday April 30 for Days Jan. 7<sup>th</sup> & 8<sup>th</sup> missed.
- South Spencer County Schools had a very successful year in 2009.
- 2010 will be facing challenges, as State Tuition Support will be reduced as much as 4.5% this calendar year. A list of cost savings considerations will be shared with all our staff for input.
- On a positive note, graduation rate for 08-09 increased to 93.6% which puts us in the top 27% in the state. Part of this is due to the alternative schools increased involvement at the high school.
- The State Board of Education voted last week to advance new teacher licensing regulations that ensure new teachers will be experts in subjects they teach.

# SSHS as one of the State's 2009 'Best Buy 'High Schools

The Study examined 357 Indiana public high schools with the appropriate available data. Using ISTEP+Pass+rates, graduation rates, SAT Participation rates and average composite scores, and Advanced Placement (AP) passing scores, the Indiana Chamber developed a total school performance index for each school. This index is called the school's quality index.

For 2009, 135 public schools were designated as a "best buy" for giving taxpayers the most value for their money. The school was named a best buy if it had quality index above the state median and revenues below the statewide median of \$10,179 per student.

All of the Best Buy schools are getting the utmost out of their taxpayer dollars by, in turn, delivering high-quality education for their students.
