## **NOTICE TO BIDDERS**

Notice is hereby given that the South Spencer County School Corporation by and through its Board of School Trustees will receive sealed proposals until **2:00 p.m., CDT, on Thursday, July 14, 2022** and not thereafter, in the Central Office of South Spencer County School Corporation, located at **321 South 5th St., Rockport, IN 47635**.

Opening will be open to the public. Said sealed proposals shall be for the furnishing of all materials and the performance of all labor according to the drawings and specifications prepared by Jack R. Kinkel and Son Architects, for **South Spencer High School Athletic Field Renovations 2022** located at **1142 N. Orchard Rd., Rockport, IN 47635**.

A mandatory pre-bid meeting is scheduled for **Wednesday, June 29, 2022 at 1:00 p.m., CDT** on site.

Copies of the Contract Documents including Project Manual and Project Drawings are available from the printing company listed below for a deposit of \$250/set payable to "South Spencer County School Corporation", which will be refunded when documents are returned in good condition, within seven (7) days after the bid opening. There is a limit of three (3) sets per Bidder, one (1) set per subbidder or supplier, under the refundable policy. Additional sets may be purchased at non-refundable printing costs. A non-refundable fee will be added for postage when necessary. Electronic media of the Drawings and Specifications in PDF format is available to plan-holders (only) from the same printing company for a non-refundable fee of \$25.

All proposals shall be made out and submitted on a bid proposal form attached to a current **General Form No 96 (can be found at <http://www.in.gov/icpr/webfile/formsdiv/index.htm> State Form Description #52414)**, a bid form prescribed by the State Board of Accounts. Any bid that exceeds a sum of \$5,000.00 must be accompanied by a Contractor's Financial Statement attached to the General Form 96 as prescribed by the State Board of Accounts. One General Form No. 96 will be required from any one contractor for one or more bids. All proposals shall be firm without escalator clauses.

The proposal must be accompanied by a certified check made payable to the South Spencer County School Corporation in an amount equal to not less than five percent (5%) of the base bid or an acceptable bidder's surety bond made payable to South Spencer County School Corporation, in a SPECIFIC AMOUNT of not less than five percent (5%) of the base bid, executed by a surety company authorized to do business in the State of Indiana. The certified check or bidder's bond shall be a guarantee that said bidder will, if the contract is awarded to him, execute within ten (10) days from the acceptance of his proposal a contract for the work bid upon, and furnish acceptable surety bonds as set forth in the specifications. However, if the contractor has not executed the contract within the ten (10) day period, or has failed to furnish acceptable surety bonds as indicated, the Board of School Trustees reserves the right to award the contract to the next higher or best bidder.

**All state, municipal and local licensing requirements must be met prior to submitting bid. All state, municipal and local licensing requirements must be met prior to submitting bid. Contractors shall hold Certification 1542.00B Institutional Buildings (Hospitals, Schools, Prisons) in excess of \$1,000,000 up to \$10,000,000.**

No bidder may withdraw his bid for a period of ninety (90) days after the date set for the opening of bids.

The Board of School Trustees of the South Spencer County School Corporation reserves the right to reject any and all bids and to waive any defects or informalities if deemed by it to be for the best interest of said Board.
