2014-123 OLD BUSINESS OF THE BOARD

Eric Ayer, upon request of the board at the last board meeting, gave report on the legalities of the School Corporation donating part of the land southeast of the LEC building to the non-profit biking club for the purpose of developing a biking trail. It is his conclusion that the school cannot gift that property to the non-profit organization. There is a procedure in the state statute that allows the transfer of property from one governmental organization to another. This means that the school corporation would have to transfer the land to the City of Rockport; who would then have to take it upon themselves to develop the biking trail and walking paths. It would also take joint resolution. One by the Board of the School Corporation to donate the property and one passed by the City of Rockport to accept the donation for that purpose. So, if the organization is interested in pursuing this, they will need to contact the City of Rockport to see if they are on board with the idea and allow the school corporation to facilitate the transfer.
