Cindy Lawrence – (parent) – Speaking about the interventionist at Luce. Stated with a school of 200 there is about 20% with needs that one teacher cannot meet. That she hopes

that with ESSER money we find a way to replace teachers that we are losing and meet the needs of more students.

Dee Meyer – (Retired South Spencer Teacher) – Talked about the importance of reading and help for classroom teachers. That the corporation needs to rethink the interventionist position at Luce Elementary.
